2. *(Where the defendant is a corporation, add: A Corporation may not enter an appearance in, or defend, any proceedings otherwise than by a solicitor or by a director authorised in accordance with Part 11 rule 1A of the Supreme Court Rules 1970.)*

3. *(Where Part 7 rule 4 applies, add: You may, within (14) days after service of this Statement of Claim upon you, pay to the plaintiff or his solicitor the amount claimed (and, where the claim is for a liquidated demand together with an order for interest under section 94 of the Act, add— together with interest at the rate claimed or at (specify the rate fixed by Part 7 rule 4) per cent yearly whichever is less, from the beginning of the period for which interest is claimed until the date of payment (or as the case may require: see Part 7 rule 4 (2)) and also \$ for costs. Further proceedings against you will be stayed when you also file a prescribed form of notice of payment.)*

4. *(Where Part 7 rule 8 (1) (a) applies, add: The plaintiff does not seek to disturb the occupation of (name of occupier).)*

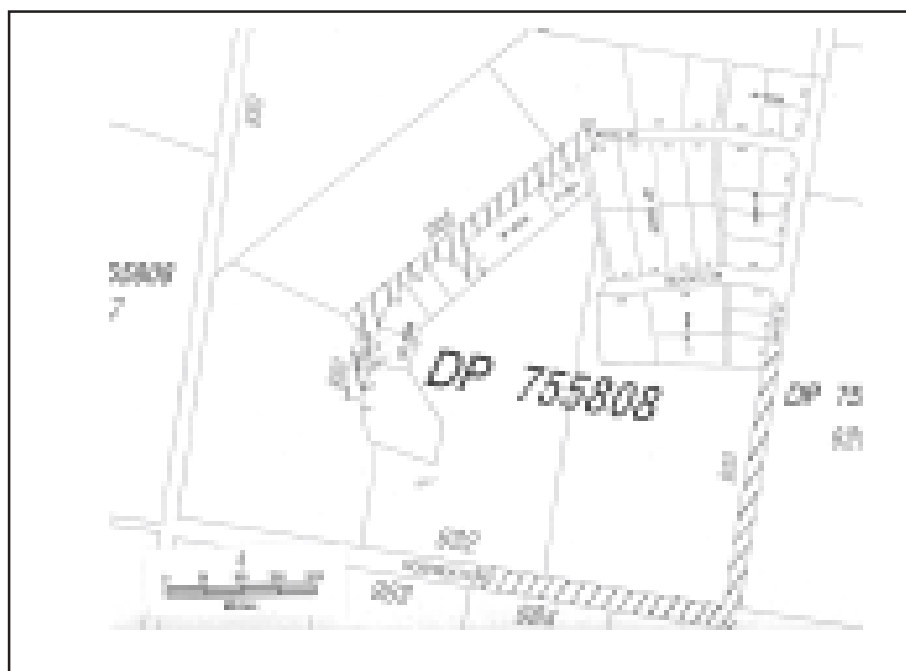

**ALTERATION OF PURPOSE OF A WESTERN
LANDS LEASE**

IT is hereby notified that in pursuance of the provisions of section 18J, Western Lands Act 1901, the purpose and conditions of the undermentioned Western Lands Lease have been altered as shown.

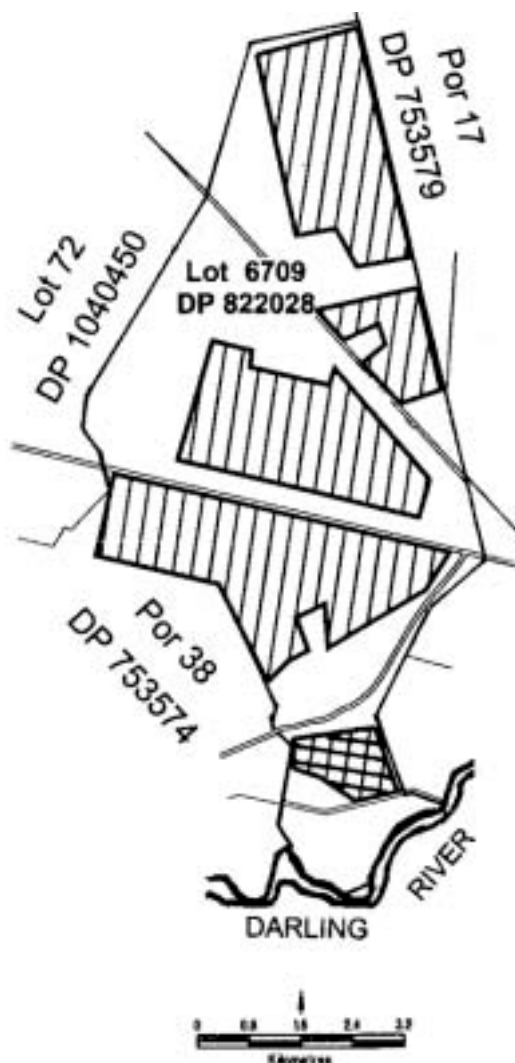
The purpose of Western Lands Leases 9428, being the land contained within Folio Identifier 6709/822028 has been altered from "Pastoral Purposes" to "Pastoral Purposes and

Cultivation" effective from 28 February 2003.

Annual rental and lease conditions remain unaltered as a consequence of the change of purpose except for the addition of those special conditions following effective from 28 February 2003.

**SPECIAL CONDITIONS ATTACHED TO WESTERN
LANDS LEASE 9428**

1. The lessee shall not irrigate outside the area of 2090 hectares indicated by hatching on the diagram hereunder.
2. Cultivation for rainfed or postflood cropping, pasture establishment or land rehabilitation purposes is permitted on abandoned irrigation land of 125 hectares indicated by cross-hatching on the diagram hereunder. The Western Lands Commissioner may at any time require rehabilitation of existing or future land degradation on this site.



3. The lessee shall ensure that cultivation and associated activities do not interfere with any road formation within the allowable area.
4. Incised drainage lines, other than man made structures, which carry water after storms shall be left uncultivated in the channels and for a distance of 20 metres on either side of the banks of the channels except when the Western Lands Commissioner specifies otherwise.
5. The lessee shall retain a 20-metre buffer either side of any bore drain within the lease.
6. The lessee shall ensure that the application of any chemicals is to be in the strict accordance with the relevant label directions.
7. The lessee shall undertake any fuel management and/or provision of fire trail access in accordance with fire mitigation measures to the satisfaction of the local bushfire authority.
8. Aboriginal Sites are protected under the National Parks and Wildlife Act 1974, and are extremely vulnerable to many kinds of agricultural development.
9. Should any Aboriginal archaeological relics or sites be uncovered during the proposed works, work is to cease immediately. The lessee must consider the requirements of the National Parks and Wildlife Act 1974 with regard to Aboriginal relics. Under Section 90 it is an offence to knowingly damage or destroy relics without prior consent of the Director-General of the National Parks and Wildlife Service (NPWS). If a site is discovered the lessee should contact the Manager, Cultural Heritage Unit, National Parks and Wildlife Services on Phone (02) 6883 5324 OR AT 58-62 Wingewarra St, Dubbo.
10. The lessee shall establish windbreaks at his/her own expense, as may be ordered by the Western Lands Commissioner to provide adequate protection of the soil.
11. The lessee shall ensure that stubble and other crop residue is retained on the soil surface and shall not be burnt, except with the approval of the Western Lands Commissioner or his delegate. Where such approval is granted and stubble burning is carried out with the approval as per requirements of the NSW Rural Fire Services.
12. The area allowed to be cultivated partly covers Travelling Stock Reserves 853, 935 and 72047. Suitable arrangements should be made with the relevant Rural Lands Protection Boards regarding the movement of stock in those areas. If suitable arrangements cannot be made with the Rural Lands Protection Board, the matter will be determined by the Western Lands Commissioner.
13. Natural wetting and drying cycles of the soil on non-irrigated parts of Western Lands Lease 9428 are not to be altered by works or strategies to harvest stormwater.
14. If the Western Lands Commissioner forms a view that land uses or land use practices are leading to a natural resource decline or social nuisance then the Commissioner may direct the lessee to rectify that decline at the lessee's expense.
15. In the event of altered circumstances or natural resource decline the Western Lands Commissioner may direct the cessation or alteration of any land uses or land use practices in use at any time and may also direct the rehabilitation of the land to native or other rainfed vegetative cover.
16. Irrigation water is not to be permanently transferred from the lease without the prior permission of the Western Lands Commissioner.
17. Tailwater and on-irrigation storm run off is to be recycled and reused on farm to the extent possible and is not to be disposed of directly or indirectly into the Darling River without the prior agreement of the Western Lands Commissioner and the Environment Protection Authority.
