Parliamentary Remuneration Amendment (Salary of Ministers) Regulation 2003

Her Excellency the Governor, with the advice of the Executive Council, has made the following Regulation under the *Parliamentary Remuneration Act* 1989.

Explanatory note

Section 6 of the *Parliamentary Remuneration Act 1989* provides for holders of certain offices specified in Schedule 1 to the Act to receive a salary and expense allowance in addition to the basic salary to which they are entitled as Members of Parliament. The additional salary and expense allowance is expressed as a percentage of the basic salary (as defined in section 4 of the Act).

At present, a Minister (other than the Premier, the Deputy Premier and the Leader and Deputy Leader of Government Members in the Legislative Council) is entitled to receive an additional salary of 67% along with an expense allowance of 26%. The object of this Regulation is to provide that only those Ministers who are designated by the Premier as Senior Ministers will receive an additional salary of 67%. Other Ministers who are not designated by the Premier as Senior Ministers will have their additional salary reduced to 57%.

This Regulation is made under the *Parliamentary Remuneration Act 1989*, including sections 6 (4) and 21 (the general regulation-making power).





Bivalve shellfish

I, IAN MacDONALD, prohibit the taking of all bivalve shellfish including mussels, cockles, pipis and oysters by any person from all estuary and ocean waters south of Wapengo Lake (north east of Bega), including Wapengo Lake, to the Victorian border.

Oysters that are taken in accordance with the provisions of the Safe Food Shellfish Program are exempt from this prohibition.

This prohibition will be effective from 4 April 2003 until 1 May 2003 (inclusive) unless varied or revoked by further notifications of the Director, NSW Fisheries.



For the same religious and legislative reasons, the Nursing Service has no intention of establishing or assisting in the maintenance of a nursing home.

The testator's gift is the basis of an application for a cy-pres scheme, submitted on behalf of the NSW Nursing Services for Christian Scientists Limited with the consent of the executor and the support of the Fair Havens Association, to apply the one-eleventh share of the residue of the Mr Crooks' estate to the Nursing Service for the subsidising of nursing services (known as 'benevolence') for Christian Scientists.

The purpose of the current Trust is to encourage specific qualities of journalism, namely independence, integrity, accuracy and lucidity. However, the Trust Deed limits the possible beneficiary of the Trust to 'freelance journalist' as defined. Given the changes to the employment and work practices of journalists since the Trust's establishment, the restriction of the award to 'freelance journalist' no longer provides a suitable and effective method of using the Trust Fund having regard to the intention of the Trust.

The Trust is, the basis of an application for a cy-pres scheme. The purpose of an amended Trust Deed as proposed by the Trustees would remain that of encouraging the same qualities of independence, integrity, accuracy and lucidity in journalism, but opens entry to the award to all journalists and not solely 'freelance journalists'.

The Solicitor General, under delegation from the Attorney General in and for the State of New South Wales, has formed the view that the George Munster Award is a Trust for charitable purposes, and has approved a recommendation that the Attorney General establish a cy-pres scheme pursuant to section 12 (1) (a) of the Charitable Trusts Act 1993. The scheme is to vary the Trust Deed in the manner proposed by the Trustees to permit the award to be applied to all journalists and not solely to 'freelance journalists'.

- The levels of PAHs, BaP and lead in the fill material at the site exceed relevant health based criteria for land used for park / recreational open space use;
- (ii) The levels of PAHs, BaP and zinc in the groundwater on the site exceed the relevant criteria for protection of aquatic ecosystems; and
- (iii) The levels of PAHs, BaP and lead in the sediment on the site exceed relevant health based criteria for land used for park / recreational open space use.

The EPA has found that the contamination of the fill material, groundwater and sediment on the site presents a significant risk of harm to the environment. In particular:

— The International Agency for Research on Cancer (IARC) has classified benzo(a)pyrene as Group 2A (Agents probably carcinogenic to humans) and lead as Group 2B (Agents possibly carcinogenic to

The making of this declaration does not prevent the carrying out of a voluntary remediation of the site and any person may submit a voluntary remediation proposal for the site to the EPA. If the proposal satisfies the requirements of s.26 of the Act, the EPA may agree not to issue a remediation order to the person or persons bringing the proposal.

application form means the form entitled Application for a Driver Authority approved by the Director-General for the purpose of dealing with applications for driver authorities.

medical certificate means a certification of an applicant's medical fitness prepared according to the medical guidelines by a registered medical practitioner pursuant to an examination of the applicant according to the medical guidelines.

medical guidelines means the standards set out in the booklet Medical Examinations of Commercial Vehicle Drivers (November 1997) published by the National Road Transport Commission and the Federal Office of Road Safety and endorsed by the Ministerial Council, as amended from time to time.

 - (d) a medical certificate that is not more than 6 months old, and
 - (e) such documentation or other evidence as the Director-General may legally and reasonably require, particularly in respect of this Part.
- (5) An application for a driver authority may be submitted either by posting or delivering it to, as the case may be, any of the Transport NSW postal or delivery addresses specified in Schedule 2.

 - (d) a medical certificate that is not more than 6 months old, and
 - (e) such documentation or other evidence as the Director-General may legally and reasonably require, particularly in respect of this Part.
- (5) An application for a driver authority may be submitted either by posting or delivering it to, as the case may be, any of the Transport NSW postal or delivery addresses specified in Schedule 2.


