RURAL FIRES ACT 1997

NOTIFICATION UNDER SECTION 99

IN pursuance of the powers conferred upon me by section 99 of the Rural Fires Act 1997, I, PHILIP KOPERBERG, Commissioner of N.S.W. Rural Fire Service, under delegation and dated 22nd October 1997 from the Hon BOB DEBUS, Minister for Emergency Services, do, by this notification, direct that the lighting, maintenance or use of all fires in the open air, with the exception of the classes of fire as specified in Schedules 1, 2, 3, 4, 5, 6, 7, 8, 9, 10, 11, 12, 13, 14 and 15 hereto, is prohibited in the parts of the State set out in Schedule A hereto, from midnight on 26th February 2001 to midnight on 27th February 2001.

SCHEDULE 1

Fire lit, maintained or used for the purpose of suppressing or controlling any existing bush fire where such fire is lit, maintained or used under the direction of the Commissioner of the N.S.W. Rural Fire Service, any officer of the N.S.W. Fire Brigade, any officer authorised by the Forestry Commission of New South Wales, any officer authorised by the Director of National Parks and Wildlife Service, or any Fire Control Officer, Captain, Deputy Captain, Group Captain or Deputy Group Captain of any bush fire brigade organised or authorised under the Rural Fires Act 1997.

SCHEDULE 2

Fire lit, maintained or used at a registered factory within the meaning of the Factories, Shops and Industries Act 1962, subject to observance of the special condition that all reasonable steps are taken to prevent the escape of fire, sparks or incandescent or burning material therefrom.

SCHEDULE 3

Fire lit, maintained or used at a hospital within the meaning of the Public Hospitals Act 1929, subject to observance of the special condition that the fire is lit in a properly constructed incinerator designed to prevent the escape of fire, sparks or incandescent or burning material therefrom.

SCHEDULE 4

Fire lit, maintained or used by, or under the authority of, a Council as defined in the dictionary of the Rural Fires Act 1997, for the destruction of garbage or other refuse at any sanitary depot provided and controlled by such Council subject to observance of the following special conditions:

- (1) a fire break shall be established and maintained around such depot to a width of not less than thirty metres;
- (2) at least one person shall be in attendance continuously at such depot for the duration of the fire;
- (3) all reasonable steps shall be taken to prevent the escape of fire, sparks or incandescent or burning material therefrom.

SCHEDULE 5

Fire lit, maintained or used by or under the authority of any person or body of persons, corporate or unincorporate, for or in connection with essential repair, or maintenance of services or equipment required for continuance or restoration of the supply or provision of heat, light, power, water, sewerage, transport or communication subject to observance of the special condition that all reasonable steps are taken to prevent the escape of fire, sparks or incandescent or burning material therefrom.

SCHEDULE 6

Fire lit, maintained or used by a Public Authority as defined in the dictionary of the Rural Fires Act 1997, for the disposal of waste or putrescent material likely to cause a health hazard subject to observance of the special condition that the fire is lit in a properly constructed incinerator designed to prevent the escape of fire, sparks or incandescent or burning material therefrom.

SCHEDULE 7

Fire lit, maintained or used between the hours of 7 p.m. and 7 a.m. for a purpose associated with the harvesting of sugar cane subject to observance of the special condition that all reasonable steps are taken to prevent the escape of fire, sparks or incandescent or burning material therefrom.

SCHEDULE 8

Fire lit by the Roads and Traffic Authority of New South Wales or its contractors for the purpose of heating bitumen in tankers, sprayers, storage units, mobile asphalt plants, mobile asphalt pavers and pavement recycling machines for road repair and construction activities subject to the observance of a special condition that adequate fire fighting equipment to the satisfaction of the Commissioner of the Rural Fire Service, or his nominee, is immediately available to prevent the escape of any such fire under circumstances as to cause or to be likely to cause injury or damage to any person or the land or property of the Crown or a Public Authority as defined in the Rural Fires Act 1997, or any other person.

SCHEDULE 9

Fire lit, maintained or used for the purpose associated with the drying of products from vineyards within Wentworth and Balranald Council areas subject to observance of the special condition that inflammable material is removed from around the heating apparatus for a distance of not less than ten metres to the specification of the Fire Control Officer.

SCHEDULE 10

Fire lit by a company contracted for the construction of a natural gas pipeline from Young to Lithgow within the Central Tablelands, Central West Slopes and South West Slopes Weather Forecast Districts provided that adequate fire fighting equipment is immediately available to the satisfaction of the Commissioner of the N.S.W. Rural Fire Service or his nominee to prevent the escape of any such fire under circumstances as to cause or to be likely to cause injury or damage to any person or the land or property of the Crown or a Public Authority as defined in the dictionary of the Rural Fires Act 1997, or any other person.

SCHEDULE 11

Fire lit, maintained or used, for the purpose of food preparation on a gas fired or electric appliance where:

- (a) such appliance is under the direct control of a responsible adult person, present at all relevant times;
- (b) no combustible material of any kind is allowed within three metres of the appliance when it is operating;
- (c) a system of applying an adequate stream of water to the appliance and its surrounds is available for immediate and continious use; and
- (d) where the appliance is not on premises containing a permanent private dwelling or is more than twenty metres from such dwelling, both the appliance and the land on which it is to be placed have been approved for the purpose by the Council of the area.

SCHEDULE 12

Fire lit, maintained or used in accordance with Regulation 27 of the Rural Fires Regulation 1997, for the production of charcoal, 'but not for the destruction of waste arising therefrom,' subject to the observance of the special condition that all reasonable steps are taken to prevent the escape of fire, sparks or incandescent or burning material therefrom.

SCHEDULE 13

"Oxy-acetylene and electric welding apparatus used in accordance with the N.S.W. Coal Mine Regulations Act 1982, for the purpose of the maintenance and repair of mining equipment subject to a special condition that adequate fire fighting equipment is available and the operation is conducted within an area identified as a colliery holding."

SCHEDULE 14

"Oxy-acetylene and electric welding apparatus used by the company contracted for the construction of an ethane gas pipeline from Young to Leppington within the Metropolitan, Southern Tablelands, Illawarra and Riverina weather forecast districts provided that adequate fire fighting equipment to the satisfaction of Commissioner of the N.S.W. Rural Fire Service, or his nominee, is immediately available to prevent the escape of any such fire under circumstances as to cause or be likely to cause injury or damage to any person or the land or property of the Crown or a Public Authority as defined in the dictionary of the Rural Fires Act 1997, or any other person."

Any conditions notified in writing by the Commissioner of the N.S.W. Rural Fire Service to individuals or organisations.







3 Court fees

- (1) The fees to be taken in the Compensation Court in respect of the matters set out in Schedule 1 are the fees specified in that Schedule.
- (2) A fee charged under this Regulation for any service is payable to the registrar of the Compensation Court:
 - (a) by the person at whose request the service is rendered, and
 - (b) when the service is rendered.

(3) However, the registrar:

- (a) may require any fee for the service to be paid before the service is rendered, or
- (b) may, by order in writing, direct that the whole or any part of the fee be postponed, waived or remitted subject to such conditions (if any) as the registrar thinks fit to impose.

Explanatory note

The object of this Regulation is to amend the *Marine Parks Regulation 1999* so as to make provision with respect to:

- (a) the nomination of members of the Marine Parks Advisory Council to represent the interests of marine conservation, and
- (b) the saving of the positions of those members of the Marine Parks Advisory Council who are affected by the amendments to section 32 of the *Marine Parks Act 1997* to be made by the *Marine Parks Amendment Act 2000*.

This Regulation also repeals Division 2 of Part 3 of the *Marine Parks Regulation 1999*. Those provisions are to be superseded by Division 3 of Part 3 of the *Marine Parks Act 1997*.

This Regulation is made under the *Marine Parks Act 1997*, including section 48 (the general power to make regulations), section 32 (the establishment of the Marine Parks Advisory Council) and clause 1 of Schedule 3 (the power to make regulations of a savings or transitional nature).

1 Name of Regulation

This Regulation is the Marine Parks Amendment Regulation 2001.

The Marine Parks Regulation 1999 is amended as set out in Schedule 1.

Schedule 1 Amendments

(Clause 3)

[1] Part 3, Division 2

Omit the Division.

[2] Clause 40

Omit the clause. Insert instead:

40 Marine Parks Advisory Council members (marine conservation interests)

- (1) For the purposes of section 32 (2) (b) of the Act, the Nature Conservation Council (the *NCC*) is the peak group or body to represent the interests of marine conservation.
- (2) If a vacancy arises in the office of the member of the Marine Parks Advisory Council appointed on the nomination of the NCC (the *NCC member*), the relevant Ministers must call on the NCC to nominate (within such period as the relevant Ministers may specify) at least 2 candidates from whom a new NCC member is to be appointed.
- (3) The relevant Ministers are to appoint, as the new NCC member, whichever of the candidates nominated by the NCC the relevant Ministers consider most suitable for appointment as the NCC member.

(4) If the NCC:

- (a) fails to nominate candidates when called on to do so by the relevant Ministers, or
- (b) fails to nominate a candidate who the relevant Ministers consider suitable for appointment as the NCC member,

the relevant Ministers may call on some other group or body to nominate candidates (an *alternative peak group*) and, in that event, the alternative peak group is taken to be the peak group or body to represent the interests of marine conservation for the purposes of section 32 (2) (b) of the Act.

Schedule 1

Amendments

- (5) Subclauses (3) and (4) apply in relation to an alternative peak group in the same way as they apply in relation to the NCC.
- (6) The amendments to section 32 of the Act made by the *Marine Parks Amendment Act 2000* do not affect the positions held by the members of the Marine Parks Advisory Council immediately before that commencement, and those members continue to hold office (subject to the other provisions of the Act) until the end of the terms for which they were appointed.



PARLIAMENTARY REMUNERATION ACT 1989

Determination Pursuant to Section 14A of the Act

REPORT:

On 22 September 2000 the Premier, the Honourable Mr Bob Carr MP wrote to the Tribunal regarding proposed amendments to the Parliamentary Contributory Superannuation Act 1971. These amendments were contained in the Superannuation Legislation Amendment (Same Sex Partners) Bill 2000.

Pursuant to section 14A(1) of the Parliamentary Remuneration Act 1989 (the Act), the Tribunal is required to determine whether proposed amendments to the Act are warranted. Section 14A(2) of the Act requires that in making this determination the Tribunal must have regard to;

a) ...the Heads of Government Agreement, that commenced on 1 July 1996, relating to the exemption of certain State public sector superannuation schemes...including whether the amendment is consistent with that agreement and

- must have regard to the effects of any proposed amendment on the present and future liabilities of the Parliamentary Contributory Superannuation Fund, and
- c) may obtain, and have regard to, actuarial advice relating to the costs and effects of any proposed amendment.

The Tribunal examined the proposed amendments carefully and was satisfied that the amendments were warranted and issued the relevant certificate pursuant to s. 14A(3) of the Act on 2 October 2000.

Subsequent to the issue of the certificate, further advice was received from the Premier on 7 December 2000 in regard to additional amendments to the Bill. Following debate in the Legislative Council, the Bill was amended to clarify the definitions of "spouse" and "de facto partner" in regard to the provisions of the Act. Having regard to the provisions of \$14A(2) the Tribunal finds that the proposed additional amendments essentially provide the same entitlements for the same group as was provided for in the Bill to which the Tribunal's certificate of 2 October 2000 applied. The Tribunal was satisfied that the proposed amendments were warranted and issued the relevant certificate pursuant to s. 14A(3) of the Act on 14 December 2000.

On 6 February 2001 the Minister for Police, the Hon Paul Whelan MP, wrote to the Tribunal advising, pursuant to s14A(3) of the Act that he intended to proceed with the amendments contained in the Bill.

DETERMINATION:

Pursuant to Section 14A (4) of the Parliamentary Remuneration Act 1989, I determine that the amendments to the Parliamentary Contributory Superannuation Act 1971, as proposed in the Superannuation Legislation Amendment (Same Sex Partners) Bill 2000, are warranted.

PRIVACY AND PERSONAL INFORMATION PROTECTION ACT 1998

ORDER

I, Robert John Debus, Attorney General, in pursuance of section 31 of the Privacy and Personal Information Protection Act 1998, by this order, make the Privacy Code of Practice entitled "Law enforcement and investigative agency access to personal information contained in public registers", which is annexed to this order, as a privacy code of practice.

This order remains in force until 1 June 2001.

Privacy Code of Practice

Law enforcement and investigative agency access to personal information contained in public registers

1. Objective of code

- 1.1 This code of practice is intended to ensure that the public register provisions in Part 6 of the Privacy and Personal Information Protection Act:
 - (a) enable nominated law enforcement and investigative agencies to access personal information contained in those registers for the purposes of fulfilling their law enforcement or investigative functions; and
 - (b) ensure that holders of public registers do not disclose to members of the public the fact that access to that personal information has been provided, if so requested by an authorised officer of the law enforcement or investigative agency.
- 2. Relevant provisions of the *Privacy and Personal Information Protection Act 1998* ("the Act")
- 2.1 Part 6 of the Act (sections 57-59) regulates the content and maintenance of, and access to, public registers.
- 2.2 Section 3 of the Act defines a public register as "a register of personal information that is required by law to be, or is made, publicly available or open to public inspection (whether or not on payment of a fee)".

- 2.3 Section 57(1) of the Act prevents public sector agencies responsible for keeping public registers from disclosing any personal information kept in a register unless the agency is satisfied that it is to be used for a purpose relating to the purpose of the register or the Act under which the register is kept (public registers and relevant enabling legislation are not established for law enforcement and investigative purposes).
- 2.4 Section 57(2) of the Act enables such agencies to require any person who inspects personal information contained in a public register to give particulars, in the form of a statutory declaration, as to the intended use of any information obtained through inspection.
- 2.5 Section 58 of the Act provides for the circumstances in which public sector agencies must suppress personal information contained on a public register, at the request of a person the subject of that information.
- 2.6 Division 3 of Part 2 of the Act provides a number of exemptions to the Information Protection Principles contained in Division 1 of Part 2 of the Act. A number of those exemptions enable law enforcement and investigative agencies to appropriately access and use personal information. These exemptions do not apply to the public register provisions of Part 6 of the Act.
- 2.7 Section 30(1) of the Act provides that a privacy code of practice may modify the application of Part 6 to any public sector agency.
- 3. Requirement that law enforcement and investigative agencies be able to confidentially access personal information contained in public registers
- 3.1 It is recognised that access to personal information held on public registers is often essential for nominated law enforcement and investigative agencies to effectively exercise their law enforcement and investigative functions.
- Such law enforcement and investigative functions include, but are not limited to, locating missing persons, persons who are under investigation, persons who are required to give evidence in proceedings (including hearings before a nominated law enforcement or investigative agency), locating the proceeds of crime, locating property in which persons suspected of engaging in criminal activity have an interest, and other investigations leading to or assisting a relevant law enforcement agency confiscate property or proceeds of crime. Public register information is often necessary to ensure that search warrants, listening device warrants, controlled operations authorities and other court processes are properly issued.
- 3.3 The effectiveness of law enforcement and investigate agency operations and the safety of members of the public may be severely jeopardised if nominated law enforcement and investigative agencies are not able to access personal information contained in public registers.
- 3.4 Law enforcement and investigative agencies should not be required to provide public sector agencies that maintain public registers with details of the purposes for which register information is sought, it being

- sufficient to state that access is required to assist them in effectively fulfilling their law enforcement and investigative functions. The provision of more detailed information could seriously compromise the privacy of individuals, as it could indicate a person has a criminal record or is suspected of involvement in crime, and could also undermine the integrity of investigations.
- It is also essential that a law enforcement and investigative agency is able to request that bodies maintaining public registers do not inform persons that information about them on the register has been accessed by that agency. There are clear public interest matters that should be considered by public sector agencies in releasing information about law enforcement and investigative agency access to registers, such as the potential for the release to compromise investigations, public safety or the safety of law enforcement or investigative officers. The public interest rationale for non-disclosure should be provided with any request to limit the release of this information. Public sector agencies should consider any request in determining whether to release such information under the Freedom of Information Act 1989 or other relevant legislation.

4. Definitions

- 4.1 Unless otherwise specified, the definitions in the *Privacy and Personal Information Protection Act* 1998 apply in this code.
- 4.2 "Access" to personal information in this code includes access by inspection, by request to the public sector agency responsible for keeping a public register that personal information be provided, and access by any other means.
- 4.3 "Authorised officer" in this code refers to an officer of a nominated law enforcement or investigative agency who has been authorised by the CEO of that agency to access public registers in the course of his or her employment.
- 4.4 "Nominated law enforcement or investigative agency" in this code refers to:
 - (a) the Independent Commission Against Corruption;
 - (b) the Police Integrity Commission;
 - (c) the NSW Police Service, or the police force or another State or Territory;
 - (d) the Australian Federal Police;
 - (e) the NSW Crime Commission; and
 - (f) the National Crime Authority.

5. Modification of Part 6 of the Act

Section 57

5.1 Subject to paragraphs 5.2-4 of this code an authorised officer of a nominated law enforcement or investigative agency has the same access to personal information on a public register, for the purpose of assisting the nominated agency to exercise its law enforcement or investigative functions, as he or she would have if the provisions of section 57(1) of the Act did not apply.

- 5.2 The application of section 57(2) of the Act is modified to enable the public sector agency, if it deems appropriate, to require an authorised officer who seeks access to the public register to provide:
 - (a) information confirming his or her identity as an authorised officer;
 - (b) confirmation by the authorised officer, or by another appropriate officer, that the personal information is being accessed to assist a nominated law enforcement or investigative agency to exercise its law enforcement or investigative functions.
- 5.3 The public sector agency may record the details of any access by an authorised officer.
- 5.4 An authorised officer, or a nominated law enforcement or investigative agency, may request that, until further notice, the public sector agency withhold from the subject of the personal information, on specified public interest grounds, details of any such access.

Section 58

- 5.5 An authorised officer of a nominated law enforcement or investigative agency has the same access to personal information that has been removed from the register, not placed on the register, or has been otherwise suppressed in accordance with section 58, where that personal information is still held by the public sector agency, as he or she would have if section 58 of the Act did not apply.
- 5.6 This access is subject to the conditions outlined at 5.2-4 above.

Section 59

5.7 The code does not modify section 59.



1. Case Law Update. 1/2 Day W'shop
